## *NSPA Award of Excellence*

### **Terms of Reference**

The NSPA Award of Excellence (previously the Silver Award) is given annually to a Nova Scotia Physiotherapist who:

1. is a member in good standing in the NSPA
2. has demonstrated outstanding contributions in one or more of the following areas:
  - a. administration
  - b. clinical practice
  - c. education
  - d. professional contribution
  - e. research

Nominations must be received by the Awards Committee one month prior to the AGM. The exact deadline shall be provided on the Nomination Form each year. Nominations must be accompanied by a completed and signed Nomination Form, including a brief description of the rationale for the nomination.

The award shall be presented at the AGM; it shall include a certificate noting the member's contribution; a souvenir gift of Nova Scotia (pottery, pewter, etc); and complimentary NSPA Branch membership for the following membership year.

The President may not receive the award while holding office.
