



# NSPPD 2012 Levy Submission Form

## Levy Information:

All members of the CPA Private Practice Division residing in Nova Scotia are automatically members of the Nova Scotia Section of the Private Practice Division. Section members approved a membership levy for 2012 via an electronic vote conducted in November 2011. All Section members are receiving this Levy Notice and are asked to submit their levy amount by no later than **February 29, 2012**.

## Levy Categories:

Levy categories and rates have not changed for 2012. As in 2010 and 2011, they are based on the number of FTE Physiotherapists working for the clinic. Owners of clinics with multiple locations should base their levy on the number of FTE Physiotherapists working at all clinic locations combined.
